Wonthaggi North Primary School depends on you to provide all relevant health information because withholding some health information may put your child's health at risk.

Wonthaggi North Primary School requires information about all parents, guardians or carers so that we can take account of family arrangements. **Family Court Orders setting out any access restrictions and parenting plans should be made available to Wonthaggi North Primary School.** Please tell us as soon as possible about any changes to these arrangements.
